

Sul Ross State University
Guaranteed Price Plan Opt-In Agreement

This agreement is entered into between Sul Ross State University (University) and the party(s) signing below (Student) to provide Student with a guaranteed tuition rate through four consecutive academic years. To qualify for the program, students must meet the following criteria for eligibility:

- 1) Student is an undergraduate;
- 2) Student is an in-state resident of Texas;
- 3) Student is an incoming degree seeking freshman or has transferred from another institution;
- 4) Student is admitted for current active semester;
- 5) Student has an active record in the system;
- 6) Student has not withdrawn from Sul Ross State University;
- 7) Student is not admitted for a subsequent degree.

Initial enrollment is the first semester at Sul Ross State University that a student registers and attends. Withdrawn and skipped semesters count toward the 12 consecutive semester to which the Guaranteed Price Plan applies.

Student may opt-in between new student orientation and initial registration payment, but no later than the 12th class day for the **initial semester eligible to enroll**. If a student's undergraduate level or resident status changes, they will be removed from the Guaranteed Price Plan and assessed traditional tuition rates.

A student choosing the Guaranteed Price Plan may pay a higher rate for tuition and fees during the first year and possibly throughout their time at Sul Ross State University. However, if costs increase and it is necessary to increase tuition, this plan will fix the rate for 12 consecutive semesters. There are no guarantees of cost savings.

I understand that **this form may be faxed to 432.837.8177 or submitted to the Cashier's Office at BAB 205, no later than noon on the 12th class day in fall and spring semesters and the 4th class day in the summer semester**. I will be assessed the Guaranteed Price Plan rate for the current semester, and I am responsible for paying any additional amount due prior to the published due date.

I understand that the deadline for eligible enrollment into the Guaranteed Price Plan is no later than the 12th class day in fall and spring semesters and the 4th class day in the summer semester.

I understand:

- Designated Tuition and Resident Tuition are fixed for 12 semesters, including summer and semesters withdrawn or skipped. Fees other than mandatory are excluded for the Guaranteed Price Plan and may increase
- My financial aid will not automatically be adjusted to cover increased costs but I may pursue additional awards through the office of Financial Aid.
- If my undergraduate level or residency status changes, I will be removed from the Guaranteed Price Plan and assessed traditional tuition rates
- The Guaranteed Price Plan rates are higher than traditional tuition, but guarantees a fixed cost of tuition for twelve consecutive semesters.

I elect to opt into the Guaranteed Price Plan program for four years (12 consecutive semesters) and agree to all the terms and conditions.
